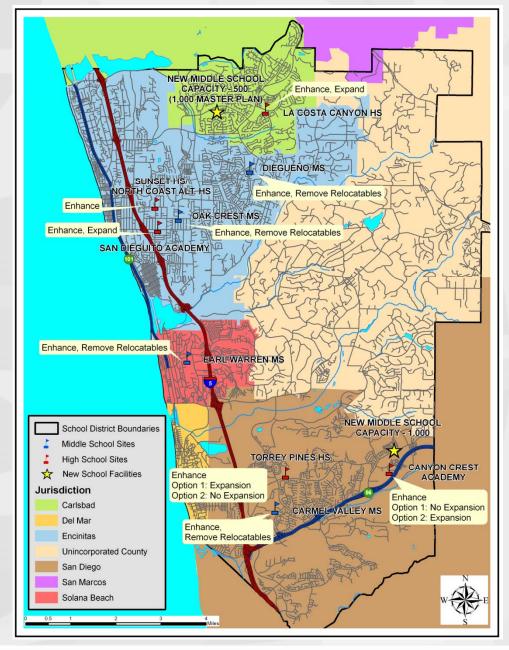

Funding Options

General Obligation Bonds

- There are two different types of GO Bonds; Proposition 46 GO Bonds and Proposition 39 GO Bonds
- Proposition 39 was passed in November 2000 allowing for a lower voter approval threshold, which has greatly increased the number of school districts able to pass GO Bonds

Description	Proposition 46 General Obligation Bonds	Proposition 39 General Obligation Bonds
Level of Voter Approval Required	Two-thirds of votes cast	55% of votes cast
Maximum Annual Tax	Not limited	High School District: \$30 per \$100,000 of assessed value
Ballot Measure	Level of detail at direction of Board; specific facilities list not required	Must list specific school facilities projects; must be certified by the Board after evaluation for safety, class size reduction, and information technology needs
Accountability Requirement	Preparation of an annual report regarding the amount of funds collected and expended, and the status of any authorized projects	Annual report plus annual, independent financial audits and establishment of citizens oversight committee with authority to audit the bond program
Election Date	Any Tuesday	Must coincide with regularly scheduled local election June 2010 November 2010



Funding Options

Financing Strategy A – District-wide GO Bond

- In a District-wide GO Bond the School District would levy a GO Bond tax on all property within the School District
- The School District would seek approval from all voters within the School District, including voters residing within existing CFDs
- There are approximately 75,000 parcels within the School District including 17,680 parcels within existing CFDs
- Financing Strategy A could generate approximately \$525 million of proceeds for school facility projects

Funding Options

Financing Strategy B - School Facilities Improvement District ("SFID")

- SFIDs allow school districts to tax only a portion of the area it serves
- SFID would allow the School District to tax only parcels outside of existing CFDs
- San Dieguito UHSD is the lead agency on11 CFDs[1] encompassing 17,680 parcels throughout the School District
- Financing Strategy B could generate approximately \$400 million of proceeds for school facility projects
