EXECUTIVE SUMMARY

Bids for construction of the 2nd Classroom Building at Pacific Trails Middle School were conducted over the course of 3 separate bid dates; May 23, 2017, June 6, 2017 and July 31, 2017. The project was bid as a multi-prime project with C.W. Driver acting as Construction Manager.

A prequalification determination question was presented to staff on June 6th, which required review by District's legal counsel. On counsel's recommendation, additional time was allotted for pre-qualification determinations and consequently only those bid packages which were not affected by the question were accepted and opened by staff on June 6th.

This action also resulted in staff's request for a Special Board Meeting on August 2, 2017 to accommodate a re-advertised bid for those bid packages affected by the postponement so that award of contract may occur within the time frame necessary to meet the construction schedule best aligned to serve educational needs.

Overall, there was a large response to the bid advertisement, ultimately with 43 prequalified firms responding over 19 bid packages. There were no prequalified contractors responding to Bid Package #2, Grading, and Bid Package #12, Flooring. District staff will re-assess these bid packages and re-advertise where appropriate.

In addition, there is one bid package, Bid Package #11 Acoustical Ceilings & Wall Panels, under protest. While District Staff believes the protest to be unfounded, we will consult legal counsel, investigate the protest and provide a recommendation to the Board at its August 17, 2017 meeting. Delaying award of this particular bid package will not affect the delivery of the building.

District Staff and the Construction Manager have reviewed the bid packages to determine the lowest responsive and responsible bidders.

The total hard construction cost for the 16 trade packages presented this date equals \$12,368.599.

SUBJECT: AUTHORIZATION OF CREATION OF SPECIAL

EDUCATION TASK FORCE

EXECUTIVE SUMMARY

A suggestion was made at a recent meeting of special education parents to establish a formal committee to provide specific input and recommendations to the administration and Board of Trustees to improve outcomes for students with disabilities.

Administration proposes the creation of a Special Education Task Force comprised of parents, teachers (both special education and general education), administrators, related service providers (such as psychologists, speech pathologists, etc.), and board members. The parents and educators would represent the broad interests of our many special education programs across the district.

The purpose of the Task Force would be to engage in a long-term strategic planning process for special education services. The meetings would include formal agendas and be publicly noticed with a planned sequence of topics to discuss over the course of the school year. The Task Force work would result in recommendations in the Spring for implementation beginning in the 2018-19 school year.

Topics to be discussed would include curriculum and alignment with California standards, post-secondary transition, parent outreach and engagement, career pathways and electives, community partnerships and involvement, professional development for certificated and classified staff, developing independence, equity and inclusion, and facilities issues.

Staff will present a process to select members for the Task Force, along with a timeline of meetings and milestones at the Special Education Workshop scheduled for August 17, 2017.

RECOMMENDATION:

It is recommended that the Board authorize the creation of a Special Education Task Force comprised of parents, teachers, administrators and other stakeholders to provide recommendations to improve the outcomes for students with disabilities.
