PUBLIC COMMENTS

At the discretion of the Board President, members of the public are entitled to speak on agenda items either immediately after the item is called or following background information provided related to the item. Members of the public are entitled to comment on an agenda item only once at any meeting. Although the Board President may seek additional information, participation in debate on any item before the Board shall be limited to the Board and staff. The Board President shall determine the order of speakers, when the Board President calls a member of the public to the podium they are asked, but not required, to provide their names prior to making comments.

Comments are limited to three (3) minutes per person and may not be increased though donations of time by other members of the public. The total public comment time for agenda items shall not exceed twenty (20) minutes.
