Since the last meeting, the ongoing closeout of the solar projects at Canyon Crest Academy and La Costa Canyon High School has yielded an additional \$123,946.48 in savings from the two school site solar budgets. Those savings have been reallocated in part to the Carmel Valley Middle School Field Improvement project to provide for significant Division of State Architect accessible pathway improvements leading from the gym area to the pedestrian ramp at the field in the amount of \$73,946.48 and to the future Oak Crest Middle School Solar project in the amount of \$50,000.00.

Bids were received on March 19, 2019 for the Carmel Valley Middle School field project. The low bid of \$1,643,000.00, along with the estimated inspection and testing costs of \$56,000.00 are in excess of the available funding of \$1,559,486.05 at this time. To bring the project within budget, one of the three proposed shade structures will be removed, and existing underlying track material will be examined to be reused in part.

The chart below incorporates the revised March 22, 2019 budget, the amounts contracted for each budget, the amount expended towards the contracted amounts, remaining budget, and project status.
