EXECUTIVE SUMMARY

The current San Diego County Public Health Orders are posted on the District's Website. At this time, we are still under orders that do not allow schools to reopen. We have not been given a timeline of when restrictions will ease to allow for some physical presence on our campuses beyond technology and food distribution.

It is not anticipated there will be an easing of restrictions that would allow for school to resume with classroom instruction prior to the end of this school year. We are carefully monitoring information as it comes from the State of California and San Diego County. Depending on the potential of easing of restrictions there may be opportunities for some presence on our campuses prior to the end of the school year. With District guidance, site principals are making plans for students and staff to retrieve items from campuses and preparations are being made for instructional material returns at the end of the school year.

The District is planning on holding summer school 2020 consistent with the current Distance Learning Plan, however, it will include graded instruction. The District is considering multiple scenarios for the first semester of the 2020-21 school year. The scenarios range from full closure under current guidelines, hybrid models, and a full reopening. The District is planning on including graded instruction in all of the scenarios.

All District decision-making will continue to focus on the health and safety of our students, families, staff and community.

EXECUTIVE SUMMARY

Based on current State of California and San Diego County Public Health Orders, the District's schools will not be able to hold traditional graduation and promotion ceremonies as called for in Board Policy 5127. The District has not been given a timeline for easing of restrictions, however, it is not anticipated that there will be a sufficient easing of restrictions to hold traditional ceremonies. Graduations and promotions are site-based and each site principal is developing contingency plans. Input is being sought from students, parents, faculty and staff.

Consistent with guidance from the California Department of Education, all students who were eligible to be **promoted** to the next grade on the date schools were physically closed, remain eligible to do so. Students who were not yet eligible are being given opportunities to become eligible during distance learning.

Consistent with guidance from the California Department of Education, all students who were eligible to **graduate** on the date schools were physically closed, remain eligible to receive a **diploma**. Students who were not yet eligible are being given opportunities to become eligible during distance learning.
