SUBJECT: ADOPTION OF RESOLUTIONS

ESTABLISHING SPECIAL TAXES FOR

2020-21 FISCAL YEAR

EXECUTIVE SUMMARY

The Board of Trustees has adopted ordinances authorizing the levy of a special tax within CFD 94-2, CFD 94-3, CFD 95-2, CFD 99-1, CFD 99-2, CFD 99-3, and CFD 03-1. These ordinances were adopted pursuant to the Rate and Method of Apportionment of Special Taxes approved in the elections. The Rate and Method of Apportionment of Special Taxes also require the Board to determine the amount for the alternate prepayment to be collected each year. The Annual Sierra West Group Material/Cost of Construction Index can increase this rate for all CFD's except for CFD 99-2 and CFD 99-3 for which the Engineering News-Record Building Cost Index is used.

The 2020-21 prepayment amounts have been established as follows:

- CFD 94-2 \$4,955.00 for a single family home and \$1,350.00 for a multi-family home.
- CFD 94-3 \$11,370.28 for a single family home and \$3,097.86 for a multifamily home.
- CFD 95-2 \$10,983.77 for a single family home and \$2,992.55 for a multifamily home.
- CFD 99-1 \$11,310.59 for a single family home and \$3,055.04 for a multifamily home.

- CFD 99-2 One-Time Special Tax of \$1.32 per square foot of assessable space for residential homes and \$0.17 per square foot of assessable space for commercial buildings located in the Rancho Santa Fe School District and \$0.30 per square foot of assessable space for commercial buildings located in the Encinitas Union School District.
- CFD 99-3 One-Time Special Tax of \$1.32 per square foot of assessable space for residential homes and \$0.30 per square foot of assessable space for commercial buildings.
- CFD 03-1 \$13,414.41 for a Tax Class A single family home, and \$3,624.39 for a Tax Class A multi-family home, \$11,310.59 for a Tax Class B single family home, and \$3,055.04 for a Tax Class B multi-family home.

RECOMMENDATION:

It is recommended that the Board adopt the attached resolutions establishing Special Taxes within Community Facilities District No.'s 94-2, 94-3, 95-2, 99-1, 99-2, 99-3, and 03-1, which increase the Alternate Prepayment Tax for single family, multi-family units, and commercial buildings per the Annual Sierra West Group Material/Cost of Construction Index or Engineering News-Record Building Cost Index.

RESOLUTION OF THE BOARD OF TRUSTEES OF THE SAN DIEGUITO UNION HIGH SCHOOL DISTRICT ESTABLISHING SPECIAL TAXES WITHIN COMMUNITY FACILITIES DISTRICT NO. 94-2 FOR PREPAYMENTS FOR THE 2020-21 FISCAL YEAR

WHEREAS, on September 22, 1994 the Board of Trustees of the San Dieguito Union High School District (the "Board of Trustees") adopted a resolution entitled "Resolution of Formation of the Board of Trustees of the San Dieguito Union High School District Establishing Community Facilities District No. 94-2 of the San Dieguito Union High School District, Authorizing the Levy of a Special Tax, the Incurrence of Bonded Indebtedness not to Exceed \$50,000,000 within Proposed Community Facilities District 94-2 and Calling an Election" (the "Resolution"), which established Community Facilities District No. 94-2 of the San Dieguito Union High School District (the "District") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, to finance the construction and acquisition of certain school facilities within the District;

WHEREAS, the Resolution authorized the levy of a special tax on property lying within the District, authorized the issuance of bonds in an aggregate principal amount not to exceed \$50,000,000 and called an election;

WHEREAS, on November 3, 1994, an election (the "Election") was held within the District in which the eligible electors approved by more than two-thirds of the votes cast the propositions of levying a special tax on property within the District, incurring indebtedness in an amount not to exceed \$50,000,000 and establishing an appropriations limit;

WHEREAS, on December 5, 1994, the Board of Trustees adopted an ordinance entitled, "Ordinance of the Board of Trustees of the San Dieguito Union High School District Authorizing the Levy of a Special Tax Within Community Facilities District No. 94-2" (the "Ordinance") authorizing the levy of a special tax within the District pursuant to the rate and method of apportionment of special taxes approved in the Election (the "Rate and Method") which is set forth in Exhibit A attached to the Ordinance (terms used but not defined herein have the meaning provided in the Rate and Method);

WHEREAS, the Ordinance authorized the Board of Trustees to provide, by resolution, for the levy of the special tax in accordance with the Rate and Method;

WHEREAS, pursuant to the Rate and Method, within five (5) business days from the time of issuance of the initial building permit with respect to any Assessor's Parcel, the owner of such Assessor's Parcel of Developed Property may elect to prepay fifty percent of the aggregate Maximum Special Tax obligation attributable to the Assessor's Parcel;

NOW THEREFORE, THE BOARD OF TRUSTEES DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. In accordance with the Rate and Method, the Board of Trustees hereby establishes \$4,955.00 as the Alternate Prepayment Tax for Single-Family units and \$1,350.00 for Multi-Family units with respect to Developed Property for the 2020-21 fiscal year.

Section 2. The Alternate Prepayment Tax with respect to any Assessor's Parcel shall be collected by the District within five (5) business days from the time of issuance of the initial building permit of such Assessor's Parcel of Developed Property in accordance with Section VII of the Rate and Method and Section 5 of the Ordinance.

Section 3. The Board of Trustees hereby ratifies any action taken prior to adoption of this resolution to collect the Alternate Prepayment Taxes with respect to Developed Property for the 2020-21 fiscal year.

Section 4. This Resolution shall take effect immediately on the date of final passage.

Parcel of Residential Property shall be subject to Annual Special Taxes and shall not be subject to the One-Time Special Tax.

NOW THEREFORE, THE BOARD OF TRUSTEES DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. In accordance with the Rate and Method, the Board of Trustees hereby establishes \$1.32 per square foot of Assessable Space for Assessor's Parcels of Residential Property, or \$0.30 per square foot of Chargeable Covered and Enclosed Space for Assessor's Parcels of Commercial Property as the One-Time Special Tax for the 2020-21 fiscal year.

Section 2. The One-Time Special Tax with respect to any Assessor's Parcel shall be collected by the District at or prior to the issuance of a building permit of such Assessor's Parcel in accordance with Section C of the Rate and Method and Section C of the Ordinance.

Section 3. The Board of Trustees hereby ratifies any action taken prior to adoption of this resolution to collect the One-Time Special Tax with respect to Developed Property for the 2020-21 fiscal year.

Section 4. This Resolution shall take effect immediately on the date of final passage.

EXECUTIVE SUMMARY

The Board of Trustees has adopted ordinances authorizing the levy of a special tax within Community Facilities District (CFD) 94-1, CFD 94-2, CFD 94-3, CFD 95-1, CFD 95-2, CFD 99-1, CFD 99-3, and CFD 03-1. These ordinances authorized the Board of Trustees to provide, by resolution, for the levy of the special tax in accordance with the Rate and Method established. The special tax will appear on each property owner's tax bill and is to be collected by the County Assessor's Office, per arrangement.

The special tax collected by the County Assessor's Office provides for ongoing debt service payments of the San Dieguito School Facilities Financing Authority Special Tax Revenue Bonds, Series 2016 and Series 2018, and CFD administrative costs. It should be noted that without a levy these obligations would go unpaid resulting in default.

The 2019/20 year saw continued moderate growth in residential housing development of 3.37% slightly increasing from 2018/19 of 2.43%, and 2017/2018 of 1.87%. Staff processed a total of 245 units permitted in four of the nine CFDs. The permits represented approval to construct 224 single family residential units (SFD) and 21 multi-family dwelling units (MFD). The majority of permitting continues in Pacific Highlands Ranch, CFD 03-1, with 213 SFD and 21 MFD starts.

Over all, the three most active community facilities districts for 2019/20 were:

CFD 03-1:

SFD – Sendero, Terraza, Cresta/Carmel, Vista Del Mar, Vista Santa Fe, Highlands, Palomar and Rancho Milagro – 213 SFD units, 21 MFD units; \$186,966.00.

CFD 95-2:

SFD - One Oak, and Rancho Summit – 8 units; \$6,400.00.

CFD 95-1:

SFD - Cielo Del Mar/The Preserve – 1 unit; \$855.00.

The additional activity will increase the total developed parcels to 10,324 parcels, and will increase the annual levy of special taxes by \$194,221.00 from \$8,501,540.50 for 2019-2020 to \$8,695,761.50 for 2020-2021.

Attachment A, "2020-21 Executive Summary", attached here, is a summary of the CFD parcel levy information for 2020-21. The detailed parcel levy information contained in Exhibit A to the resolutions is available for public inspection in the Facilities Planning and Construction Department.

RECOMMENDATION:

EXECUTIVE SUMMARY

Staff will present to the Board of Trustees an update on the planning for the 2020-21 academic year. The presentation will include the following:

- Local Conditions
- Current Guidelines, Mandates and Orders
 - California Department of Public Health
 - San Diego County Public Health Order
- Reopening Focus Areas
 - Health and Safety
 - Operations
 - Social and Emotional
 - Family and Community Engagement
 - Learning and Instruction

The Board is asked to consider and take action on the timeline for implementing the Distance Learning Model.

Dr. Wilma Wooten, San Diego County Public Health Officer, issued a new Public Health Order, effective 12:00 AM July, 21 2020. Section 4 of the Order reads as follows:

"All public, charter and private schools shall not hold classes on the school campus, and shall conduct distance learning only as required by COVID-19 and Reopening In-Person Learning Framework for K-12 Schools in California, 2020-2021 School Year issued by the California Department of Health Services on July 17, 2020 available at https://www.cdph.ca.gov/Programs/CID/DCDC/CDPH%20Document%20Library/COVID-19/Schools%20Reopening%20Recommendations.pdf. Colleges and Universities shall not hold classes or other school activities where students gather on the school campus, except for research-related activities in colleges and universities and where necessary to train students who will serve as essential workers."

The California Department of Public Health as directed by Governor Newsom, issued new orders and guidance for all K-12 schools in the State of California on July 17. In the document, "COVID-19 and Reopening In-Person Learning Framework for K-12 Schools in California, 2020-2021 School Year (Attached)," a new mandate was issued regarding "in-person reopening criteria:"

"Schools and school districts may reopen for in-person instruction at any time if they are located in a local health jurisdiction (LHJ) that has not been on the county monitoring list within the prior 14 days.

If the LHJ has been on the monitoring list within the last 14 days, the school must conduct distance learning only, until their LHJ has been off the monitoring list for at least 14 days."

San Diego County as a local health jurisdiction is on the California Coronavirus Monitoring List and has been since earlier in the month of July. Based on the above, this precludes SDUHSD from reopening for on-campus instruction until we are off of the list for fourteen consecutive days. A timeline would be as follows:

August 10 – San Diego County must be off of the list on this date if SDUHSD is to open for any on-campus instruction for our first day of school on August 25.

August 10-24 - If San Diego County is off the list, but goes back on the list between those dates, SDUHSD is then precluded from on-campus instruction.

August 25 and Beyond - If San Diego County is off of the list, and SDUHSD reopens for oncampus instruction, but San Diego County goes back on the list, SDUHSD then <u>may</u> be required to close schools for on-campus instruction.

Additionally, the State of California has issued requirements for testing that, at this time, San Diego County may not be able to accommodate. There is also uncertainty about how staff and students will be subject to quarantine for positive tests and/or exposure to others who had a positive test (see attachment). There are also exclusion or quarantine restrictions for individuals showing symptoms without having a positive test.

All of the above makes it very difficult to plan for consistent on-campus instruction for our students. We need to provide some flexibility for a safe return for students to be on campus, however, we also need to provide some planned stability for our students, families, staff, and teachers.

RECOMMENDATION:

It is recommended that the San Dieguito Union High School District operate on the Distance Learning Model for the entirety of the first quarter of the 2020-21 academic year. Staff will monitor the San Diego County Public Health Order and when the district is allowed to bring students on campus, although remaining in the Distance Learning Model, the district will do so prioritizing special education students, English language learners, high-risk students, students with inadequate learning environments, and then all other students. All on-campus activity will follow the California Department of Public Health Guidance for K-12 schools.

COVID-19 and Reopening In-Person Learning Framework for K-12 Schools in California, 2020-2021 School Year

July 17, 2020

Overview

California schools have been closed for in-person instruction since mid-March 2020 due to the COVID-19 pandemic. School closures to in-person instruction were part of a broader set of recommendations intended to reduce transmission of SARS-CoV-2, the virus that causes COVID-19. CDPH developed the following framework to support school communities as they decide when and how to implement in-person instruction for the 2020-2021 school year. New evidence and data about COVID-19 transmission, including variations by age, and the effectiveness of disease control and mitigation strategies continues to emerge regularly. Recommendations regarding in-person school reopening and closure should be based on the available evidence as well state and local disease trends.

The CA <u>School Sector Specific Guidelines</u>, and the Centers for Disease Control and Prevention <u>CDC</u> have published additional guidance on school re-entry.

In-Person Re-Opening Criteria

Schools and school districts may reopen for in-person instruction at any time if they are located in a local health jurisdiction (LHJ) that has <u>not</u> been on the county¹ monitoring list within the prior 14 days.

If the LHJ has been on the monitoring list within the last 14 days, the school must conduct distance learning only, until their LHJ has been off the monitoring list for at least 14 days.²

- ¹ School districts in LHJs that are cities are considered to be included as part of the county if the county is on the monitoring list.
- ² A waiver of this criteria may be granted by the local health officer for elementary schools to open for in-person instruction. A waiver may only be granted if one is requested by the superintendent (or equivalent for charter or private schools), in consultation with labor, parent and community organizations. Local health officers must review local community epidemiological data, consider other public health interventions, and consult with CDPH when considering a waiver request.

Guidance Once Re-Opened to In-Person Instruction

How should schools think about testing?

Once schools are re-opened to at least some in-person instruction, it is recommended that surveillance testing be implemented based on the local disease trends. If epidemiological data indicates concern for increasing community transmission, schools should increase testing of staff to detect potential cases as lab testing capacity allows.

Who should be tested and how often?

School staff are essential workers, and staff includes teachers, paraprofessionals, cafeteria workers, janitors, bus drivers, or any other school employee that may have contact with students or other staff. School districts and schools shall test staff periodically, as testing capacity permits and as practicable. Examples of recommended frequency include testing all staff over 2 months, where 25% of staff are tested every 2 weeks, or 50% every month to rotate testing of all staff over time.

What if a school or school district reopens to in-person instruction, but the county is later placed on the county monitoring list?

Schools should begin testing staff, or increase frequency of staff testing but are not required to close.

(†) A contact is defined as a person who is <6 feet from a case for >15 minutes. In some school situations, it may be difficult to determine whether individuals have met this criterion and an entire cohort, classroom, or other group may need to be considered exposed, particularly if people have spent time together indoors.

(††) A cohort is a stable group with fixed membership that stays together for all courses and activities (e.g., lunch, recess, etc.) and avoids contact with other persons or cohorts.

Guidance on School Closure

What are the criteria for closing a school?

Individual school closure is recommended based on the number of cases, the percentage of the teacher/students/staff that are positive for COVID-19, and following consultation with the Local Health Officer. Individual school closure may be appropriate when there are multiple cases in multiple cohorts at a school or when at least 5 percent of the total number of teachers/student/staff are cases within a 14-day period, depending on the size and physical layout of the school.

The Local Health Officer may also determine school closure is warranted for other reasons, including results from public health investigation or other local epidemiological data.

If a school is closed for in-person learning, when may it reopen?

Schools may typically reopen after 14 days and the following have occurred:

- Cleaning and disinfection
- Public health investigation
- Consultation with the local public health department

What are the criteria for closing a school district?

A superintendent should close a school district if 25% or more of schools in a district have closed due to COVID-19 within 14 days, and in consultation with the local public health department.

If a school district is closed, when may it reopen?

Districts may typically reopen after 14 days, in consultation with the local public health department.
