## **Current Status - Quarter 1 Distance Learning Model Board Action on July 30, 2020, Updated to Include Quarter 2 on September 17, 2020**

San Dieguito Union High School District will operate on the Distance Learning Model for the entirety of the first quarter of the 2020-21 academic year. Staff will monitor the San Diego County Public Health Order and when the district is allowed to bring students on campus, although remaining in the Distance Learning Model, the district will do so prioritizing special education students, English language learners, high-risk students, students with inadequate learning environments, and then all other students. All on-campus activity will follow the California Department of Public Health Guidance for K-12 schools.

## Recommendations:

- Adopt the resolution as presented
- Continue to implement the Board action in quarter 1 bringing more students on our campuses
- Continue with the Distance Learning Model allowing students to learn on campus or at home
- Middle Schools - Provide a choice for students to be on campus beginning in quarter 2 with a target date of 1 day per week on or before November 9 and 2 days per week on or before November 30
- Comprehensive High Schools - Provide a choice for students to be on campus beginning in quarter 2 with a target date of 1 day per week on or before November 16 and 2 days per week on or before December 7
- Plan for a return to on campus instruction for all students, with a distance learning option for those students who cannot access campus, for quarter 3
