#### 3. 2016-17 BUDGET & PROGRAM PLANNING

Mr. Dill reported on the Governor's Proposed Budget including Local Control Funding Formula (LCFF), preliminary enrollment projections, the Local Control and Accountability Plan (LCAP), LCAP State priorities, SDUHSD LCAP goals, budget themes for 2016-17, as presented.

The Board reviewed the budget themes for 2016-17 which included 1) increasing student achievement / college & career readiness, 2) school safety & connectedness, 3) arts & athletics, 4) general staffing, and 5) facilities, as presented.

A Board discussion was held regarding counselors, class size, campus safety and a variety of extra- and co-curricular activities. The Board was interested in decreasing class size, increasing counselors, increasing staffing to support campus supervision, and providing additional arts support.

Mr. Dill presented on Proposition AA funding, preparing for Series C, potential Prop AA projects, Community Facilities Districts funding, potential CFD bond projects to Supplement Prop AA, School Safety, solar projects and shared use. Mr. Dill reported on other capital projects for 2016-17 as requested by sites, and next steps for the General Fund and Facilities Prop AA and CFD bonds.
