1. CALL TO ORDER

President Herman called the meeting to order at 4:30 PM. Ms. Schultz read the meeting protocol instructions.

2. Public Comments

Public comments were moved to be heard after Item #3 below.

INFORMATION ITEMS

3. Special Education Continuum of Services

Mr. Miller introduced Meredith Wadley, Director of School & Student Services. Mr. Miller and Ms. Wadley made a presentation which included information on California Special Education Task Force, the Administrative Services reorganization and areas of oversight, Program Supervisor's support, SDUHSD special education by the numbers, due process complaints, special education budget, North Coastal Consortium for Special Education (NCCSE), SDUHSD Continuum of Services, IDEA categories, SDUHSD programs and related non-public programs, and IDEA transition services. Mr. Nathan Molina gave a brief update on the Workability and Transition Partnership Programs. Ms. Wadley continued with information on continuous improvement, special education goals for 2017-18, and disabilities categories definitions, as presented.

*2. Public Comments (heard after Item #3)

Comments were made by Cathy Sciarappa regarding access to the ATP report from Mr. Greene, her concerns with student—teacher ratio and the number of aides, training, and transportation to/from MiraCosta and jobs related to the ATP program. May Marr made comments regarding accountability and requested an in-depth review of the data. Lucile Lynch made comments about what she thought was not covered in the board workshop, teacher support and resources, the curriculum and courses offered to special education students and data regarding failing students. Janet Schenker commented on the data contents of the workshop, the special education graduation rates, accountability of the board, diploma bound students and transition services. Amy Flicker commented on the MSLA program that is doing well, transition services, and placements and caseloads. Julie Cheeseman commented about attorney fees, lack of communication, transparency issues, and requested more parent input. Krista Hogan commented on the programs available in the district, and that the general education teachers are uneducated in special education. Melanie Landers commented on the reasons why parents are filing due process complaints.
